- 14. Month by Month Contributions to each hedge fund holding (including hedge fund of funds) since your plan's initial investment up to 1Q24.
- 15. Month by Month Returns (net of fees) earned by your plans for each hedge fund holding (including hedge fund of funds) since initial investment up to 1Q24.

If you deny all or any part of this request, please cite each specific exemption you think justifies your refusal to release the information and notify me of appeal procedures available under the law.
