Course Overview

Adult Care Workers are frontline staff who help adults with care and support needs to achieve their personal goals and live as independently and safely as possible. To work in care is to make a positive difference to someone's life when they are faced with physical, practical, social, emotional or intellectual challenges.

Adult Care Workers may work in residential or nursing homes, domiciliary care, day centres, a person's own home or some clinical healthcare settings...

In addition to helping adults who need care and support, Lead Adult Care Workers have responsibility for providing supervision, frontline leadership, guidance and direction for others, or working autonomously, exercising judgement and accountability.

By providing leadership, guidance and direction at the frontline of care delivery you will be instrumental in improving the health and wellbeing of those receiving care and support.

Senior Healthcare Support Worke

Level 3 (18-21 months)

Course Overview

Apprentices will work towards the Level 3 Senior Healthcare Support Worker knowledge, skills and behaviour, gaining key skills needed in the healthcare sector. They will show competence through producing a portfolio of evidence, workplace observations, Q&A as well as assignment-based tasks, taking part in class delivery and theory sessions, functional skills (where applicable).

The programme will be delivered through synchronous and asynchronous learning, accessing a combination of blended learning consisting of face to face tutor-led teaching sessions as well as online training and independent study.

We offer a variety of pathways; adult nursing, maternity support, theatre support and allied health profession therapy support.

Course Content

During the apprenticeship, apprentices will study and learn the knowledge, skills and behaviours which will prepare for the End Point Assessment:

- Roles and responsibilities of a healthcare assistant
- How to communicate effectively with others, including patients, colleagues and other professionals
- Legal requirements of working in a healthcare environment, including safeguarding, handling information, health and safety
- Promote duty of care
- Promote the health and well-being of individuals
- Support a person-centred approach

Course Overview

The Lead Practitioner in Adult Care will guide and inspire team members to make positive differences to someone's life when they are faced with physical, practical, social, emotional, psychological or intellectual challenges. They will have specialist skills and knowledge in their area of responsibilities which will allow them to lead in areas such as care needs assessment, occupational therapy, physiotherapy, rehabilitation and enablement, telecare and assistive technology.

They will be a coach and mentor to others and will have a role in assessing performance and quality of care delivery.

Leader in Adult Care Level 5 (21-24 months)

Course Overview

They will be a leader of the care team and will develop and implement a values-based culture at a service or unit level. They may be responsible for business development, financial control, organisational resilience and continuity as well as for managing risk and leading on organisational change.

A Leader in Adult Care has responsibility for managing community or residential based services. This role has a large element of leadership, whether with other care workers and networks or in leading the service itself.
